# Review last meeting's minutes

## Landscaping review

Quotes on tree trim in the park? Joe is still working on getting quotes. Still awaiting quote from Randy at the time.

Front entry ways redo; Don submitted pictures of other communities he saw where the rocks had a good aesthetic appearance; will review cost of river rocks; need to cubic measurements from Don; he'll submit those via email after the meeting. Board will proceed once we have the costs locked down.

## **Finance review**

No finance changes from last month.

### Infrastructure review

Working on finalizing compliance structure; Phil still wants to head that up; will have a special session here in a few weeks to hash that out. Joe pointed out that he noticed a few issues; he will get the addresses and send out notices to those residents. There is a camper in Horizon Court that needs citing.

Next Months meeting will fall on the Memorial Day holiday weekend- anyone open to a team call on another day for a virtual meeting? If we need a different day Tuesday's and Fridays are good for me; Tues the 31<sup>st</sup> or Friday the 3<sup>rd</sup>? It was openly decided on the 3<sup>rd</sup>

(Editor's note; the number of weeks for May was miscounted at the time; the 4<sup>th</sup> Monday of May is the 23<sup>rd</sup>, not the 30<sup>th</sup>; these minutes have been annotated to note that this was caught at the last minute, and May's meeting will be cancelled due to illness and resignations as the Board regroups for June's meeting.)

We need to schedule the File Day- go through all of the files in the shed. We really should just pick a weekend day in May and make it happen. Will schedule that with other board members.

# **Opened the End of the Meeting for Questions**

One resident asked about tree over the property line; advised that the state law on this indicates that the tree can be cut back to the property line. Please make sure to discuss with your neighbor beforehand to avoid issues.

One resident had been in contact with T&M; saw the notes about cat-calling and thought he would get fired; previous president back in December 2021 signed a three-year contract with Frank C. as co-signee with T&M to retain him for landscaping; the rest of the board at the time was not consulted on this action. Contract will remain intact despite this irregularity. If T&M has an issue or question for the LDS Board, they need to contact the Board directly, not through neighborhood back channels.

Several residents brought up concerns about non-residents in the park at night. Some residents have approached and confronted these non-residents. Possible to get more lighting in the park at night? It was noted that the park closes at 8pm and no one should be in the park. Advise to call the non-emergency line to trespass non-residents from the park. Resident pointed out the gazebo had been marked with tape for possible future spot/flood lights to be installed. This will be considered.
