# Treasurer Summary Report

#### Revenue Update

 Estoppel & Late Fee Revenues – To date \$5.3K has been collected with \$2.8K outstanding for a total of \$8.1K in potential funds for 2023 LDS project work to be decided upon. Priorities for this spending are being collected to date.

#### Expense Update

- Pressure washing costs of \$1.3K Expected to hit in August Actuals.
- Future project planning for favorable YTD spending \$5.0K available funds is underway. Entrance work being the primary focus.
- Communication around Holiday spending starting up.

#### Balance Sheet

• The current available cash of \$60.4K (\$37.4K Checking - \$23.0K in Savings) in Fairwinds Credit Union. Available funds in checking to cover remainder of year spending.

- Park sidewalk cleaning- Thank you to T&M Landscaping for completing the pressure washing
  job in the park! It took 3 days and was just completed this morning (7/25).

#### Compliance/Violation updates – Phil (Rachel presented in Phil's absence)

- 31 compliance letters were sent out at the beginning of July.
- We will continue to evaluate and send out notices as needed.
- Completing a compliance walk in the next week additional notices will go out in early August.

#### General Updates - Rachel

- Garage Sale moving date to Nov 12th to avoid Thanksgiving week.
- August meeting motion by Rachel to cancel the August meeting due to multiple schedule conflicts – seconded by Brian
  - Because we have two board seats open, we will call a special meeting if we need to appoint a new director. We wouldn't want to wait until the September meeting for this.
- Ongoing meeting cadence discussed the possibility of moving back to quarterly board meetings. We will revisit in September.
- Notices for annual meeting/dues will start to go out in the next month or so:
  - The first notice needs to be out by September 6<sup>th</sup>
  - Letters of Intent to run for the 2 available seats need to be received by September 26th.
  - Second notices (with the voting ballots and candidate resumes) will go out the first week of October
