Your 4 digit lot number is listed on your annual HOA invoice

Where are the meetings held and can I attend a meeting?

Meetings are open. They are held twice a month. Meeting dates and times are on the Loma Del Sol HOA web site and posted on the bulletin boards at both entrances. Meetings are virtual and every quarter there is one held at the Northeast Region Sheriff's office - 1100 Dunson Rd. Davenport.

Meetings are not held if there are no requests.

How long is an ARB approval good for?

When approved it should be started as soon as possible and completed within 365 days after approval.

How long does it take to receive an approval?

- We try to approve as soon as possible usually within 14 days and can take up to 30 days depending upon the request.

I'm going to be doing major renovations on my house, windows, roof etc. how do I provide the necessary detail? Your vendor should be providing detail and specifications on your quote. For example a quote should have specifics such as what type of window style or roofing material that will be used.

Windows are required to be grid or prairie style

Preferred roofing material is architectural shingles with a fungus resistant 220 pounds or better.

All applicable county building permits must be acquired and all county codes must be followed.

Why can't we electronically submit requests?

The HOA does not own a system that can manage electronic requests at this time. All work is done by committee members using their own systems. We do communicate via email or phone if questions come up related to your request.
