- Purchased new sign for the park with the rules other one was vandalized cost \$164

• Compliance/Violation updates - Louie

- Since January sent over 100 letters of concern thank you to everyone for the good response to those
- o Current system is working we are proposing new fine system later in the meeting

- Palm trees are big issue right now

New Items of Business:

- Dead Bushes along Ronald Reagan have been progressing two proposals 1 for dead bush removal, trim 4 oak trees along road, 1 palm tree along property line. \$9,000 Proposal 2 Just dead bushes \$6,500 - Briggs was only company that responded - reached out to many companies - Debbie wanted to reach out to other companies and try to get additional quotes - Rachel asked what the risk to waiting on this task - Louis asked Don for insight -Dead bushes continue to be dead. Not sure why some are dying and others are thriving. No harm to keeping them there but they look awful. Louis recommended pro Rachel motioned approving proposal 2 - Brian seconded 5 For 1 against.
- Gazebos in park there is carpenter ant damage and rot Don did a temporary fix, but will need to get repaired - it is a hazard - Whole gazebo shouldn't need to be replaced just parts - We will need to get estimates and get it done sooner rather than later - Debbie volunteered to get estimates.
- Ground Maintenance Quotes don't have final quotes table until next meeting Current landscaping contract has expired - he is still working sand honoring current contract but have gone to RFP with existing and other companies
- Fine Policy for Compliance Directors reviewed proposed fines process Would be managed by board/compliance committee - fines would be put in place after 3rd notice before lawyer - Louis read the document - Opened the floor for this matter only recommendation to have them sign and return the notice - question about possibility of other delivery options (electronic, etc) to avoid additional postage cost - suggestion to add the postage cost to the fine - if delivered electronic you can add a read receipt.

- Rosalinda Wrote a letter in reference to the late fees and estoppel fees received an answer from President Didn't know that new accounting firm kept the estoppel fees where the previous accountant didn't that's less money to the HOA all accounting firms keep the estoppel fees so it wasn't an option. There are some in the neighborhood who can complete the forms so the HOA gets the fee Louis said we can explore that option Anyone interested reach out to the board.

 landscaping and grass instead of signs. Focus on landscaping behind the existing sign.
 Can we trim the trees that are on the island?
- Lizbet Landscaping at the entrance can we change them out for each season? Made some suggestions for plants and trees. Communication - is there a way to communicate updates and when work is being done so interested people can volunteer - Louis has been looking into text alert options for those who opt in.
