**Call Meeting to Order** – Louis called the meeting to order at 10:02 a.m.

- · Reading and approval of the minutes from previous meeting
  - o Rachel reviewed the minutes from last meeting.

## **Regular Business:**

- Treasure Report Rachel
  - o Introduction of Lorie Fulkes from HMI Management
    - We are right on budget even with several increases that were expected: insurance, lawyer, accountant firm and new landscape company
    - All money is at South State Fairwinds accounts fully closed
    - About 10 owners have not paid dues from last year
    - 288 owners have paid this year 100 still outstanding
    - \$119,721 in both accounts reserve and operating accounts

- Resident raised a question about the mailings why the first mailing did not have the invoices.
  - That was a clerical error. HMI sent the invoices separately and covered the cost of that mailing no additional cost to the HOA.
- Resident raised a question about online surcharge to pay dues. Those surcharges are set by the credit card partner – unfortunately HMI doesn't control those fees.
- Review of 2024 financials
  - Moved to new lawyer
  - Working to put money back into neighborhood (landscaping, upgrades)

#### Grounds & Landscaping

- Landscaping and Water Issues/Updates
  - Dying palm tree under warranty with new company will be replaced at no charge
  - Landscaping projects will continue to next year
  - Added new landscaping to the entrances, pulled out dead bushes
  - Working on bids for tree trimming (magnolias, remove trees at entrances that are blocking views and add sod)
    - Reviewed bid for tree trimming Rachel motioned to approve bid for tree trimming,
       Brian seconded, all voted in favor
    - Reviewed bid for repairs to the west side irrigation switch Rachel motioned to approve bid, Don seconded, all voted in favor
    - Reviewed bid for mulch Quote was too high Louis motioned to request an
      updated quote with clarification on the scope of work, Debbie seconded, all voted
      in favor \*11/14 updated quote of \$1400 was approved through teams
      communication by 5 board members.
- Review of Projects from FY24
  - Completed a speed study waiting on results from county possibly lower speed limits
  - Contacted county to paint road lines and review lanes at entrances
  - Street light replacements are happening now Duke energy is handling started before hurricane and should resume soon
- Project Scope for FY25
  - Gazebos at the park been talking about this for a year structural integrity getting worse needs to be addressed soon
- o Drain work needed in easements- timeline and estimates
  - SW FL water mgmt district we are up for inspection this year we will likely fail inspection
     will possibly need to pay to make improvements to pass inspection
  - Asked for volunteers to help coordinate these efforts. If interested please reach out.

- A resident asked who to contact when we see urgent issues (sprinklers for example). Directors will research a way to contact the directors without giving out their personal numbers (Google phone numbers).
- Arthur questions about budget. What is in the storage unit? Paperwork, files, holiday decorations, garage sale signs, etc. What is included in Office expense? mailings, paper supplies, printer ink, etc. We can see the budget but we haven't seen the actual expenses. HMI will add balance sheet to the portal so it is available to residents.
- Daniel On street parking created issues with cars needing to pass a parked car and almost collisions. Sometimes it blocks the street. County issue, HOA doesn't have jurisdiction. Call non-emergency police number if it is an issue. Possibly complete survey to allow parking only on one side of the street county would complete and enforce. Cameras at the entrance? We have considered but it is very expensive. Daniel volunteered to assist and pull information. There is a lot more activity at night so cameras may be helpful. Neighborhood watch?
- Rick thanked the board for their service and time.
- Roberta Enhance the playground kids don't have a place to play outdoor GoFund Me Campaign? –
  could be done but has to be owner initiated can't be driven by the board. Farmers Market/ Holiday
  Market insurance issues we held an event in the past but county shut it down.
- What's going on with the welcome committee? Non-existent right now. We had some momentum but need volunteers.
